Serialization software with online print, verify and aggregation systems as per GS1 /country specific guidelines for different level of packing Primary, Secondary, Secondary – II, Tertiary & Palletization.

Graphically animation of live screen is available to view each module status batch wise, UID used at each module, Rejection Ratio, Current status and pending job.

Software

- Line manager is designed on windows based software
- Main Function is to communicating with different packaging level of module in production line depend on packing level required at the time of packing.



Operation

- **Sampling:** To take the specimen for QC, Production, Shift change over etc..........
- Replace UID: Replacement of UID is possible in case of damage or other operational needs even after aggregation but before batch close
- De-aggregation: Due to any reason if De-aggregation required for aggregated data for further process can be manage from CSPL LM
- Reprint: We can reprint the aggregated label in case of label damaged by using the High level authority
- **De-commissioning:** Damaged UID can be destroy during the production due any reason
- Suspend Job: Suspension of job in case of break down, data can be transfer to next packing line or to Level 4/5, ERP or Net folder
- Close Batch: For final batch / XML report generation after completion of Batch


